Mr. McGraw beneficially owns 10,705,483 shares of the outstanding common stock of the Issuer, which includes: (i) 4,656 shares of common stock owned by Mr. McGraw individually; and (ii) 6,049,483 shares of the Issuer held by Mr. McGraw through the Communications Systems, Inc. Employee Stock Ownership Plan ("CSI ESOP"). Mr. McGraw is also a trustee of the CSI ESOP. As of December 31, 2011, the CSI ESOP held 494,992 shares of the Issuer based on information provided by CSI. Mr. McGraw disclaims beneficial ownership of any shares of the Issuer held by the CSI ESOP in excess of the shares allocated to his individual CSI ESOP account, which totaled 6,049,483 shares.

0.1% based on 8,460,625 shares of the Issuer's common stock outstanding (on average) for the three-month period ending September 30, 2011 as reported in the Issuer's Form 10-Q filed November 10, 2011 and including all 10,705,483 shares that could be deemed to be beneficially owned by Mr. McGraw. If all shares held by the CSI ESOP allocated to accounts other than that of Mr. McGraw were included in the number of shares beneficially owned by Mr. McGraw, Mr. McGraw would hold 499,648 shares of the Issuer, or 5.9% based on 8,460,625 shares of the Issuer's common stock outstanding (on average) for the three-month period ending September 30, 2011 as reported in the Issuer's Form 10-Q filed November 10, 2011.
